

Terms and conditions for bidder:

1. Interested bidders may bidder may visit the office on any working day to get the information institute any working days.
2. The bidders should have registered firm with GSTIN No.
3. The reserve price of mixed condemnation material (old Practical file etc. is Rs. 14.00 + GST and waste card board cartons per KG is Rs. 11.50.00 +GST, old answer seat, old patient admission file and old news paper is Rs. 12.00 + GST.
4. All the above said material will be auctioned through open auction. The successful bidder will be bound to deposit the Rs. 20,000/- on auction day and the rest at the time of lifting. On failure, the Security Deposit will be forfeited without assigning any reason.
5. Security Deposit for bidding is Rs. 20,000/- (Twenty Thousand Only) will be accepted in Demand Draft/cash in the office at the time of auction. Only one bidder with one other member will be allowed in auction.
6. The final payment as per weight determined at Dharma Kanta (place where the materials are weighed at weighing platform) and shall be paid by the contractor in the form of Cash/Demand Draft before taking the final delivery of the auction material.
7. Bidder will provide an undertaking that he will disfigure/ shredder before final disposal. The concerned agency/firm shall be bound to lift on "as & where basis" and no shifting or segregation of material shall be allowed. Depending on the quantity of material, estimated amount as intimated by the Institute will be deposited by the firm before lifting the raddi. The total amount shall be deposited through cash/RTGS/Demand Draft with the Institution cashier and the original receipt should be submitted as proof. The weighing of the raddi shall be got done in the presence of committee constituted by the Institute for the purpose at "dharma kanta".
8. The open auction will be on 28.05.2026 at 11:00 AM College Council Room of the Institute.
9. Any other condition as may be deemed appropriate shall be announced at the time of open auction.
